


Image1- Anti-ragging Committee composition and information with contact details.

1. Grievance Redressal Policy

College has systematic mechanism for the redressal of students' grievances. Students Grievance redresser cell is functioning in the college. If the student has any grievance on non-academic issues, she/he may approach the Teacher incharge/ Department Head/ Student Development Officer. If it doesn't get resolved there, the matter may be reported to the Principal who refers it to the grievance redressal cell.

The cell looks into the grievance and makes its recommendations to the Principal. In order to address the grievances regarding academic matters, a four-level redressal mechanism is envisaged. Complaints regarding evaluation shall be brought to the notice of the teacher concerned. If the student is not satisfied with his/her decision, he/she may appeal to the Departmental Head.

The student shall also have the freedom to make a further appeal to the College Grievance Redressal Cell. Complaints can be filed OFFLINE in grievances box or Telephonic Conversation with any member or by direct visit to member.

If the student is not satisfied, he/she may appeal to the University Level Grievance Redressal Cell which consists of Pro-Vice Chancellor, Affiliation Committee Convenerand Controller of Examinations.

2. Sexual Harassment Policy

In compliance with the instructions of National Commission for women and guidelines issued in implementation of the directives of Hon'ble Supreme Court Judgement dated 13th August, 1997 on the subject of sexual harassment of women in the workplace, This Committee in the college has now been re-constituted on July, 2018 based on the recommendations of Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act and Rule 2013, as well as Handbook on Sexual Harassment of Women at Workplace by Ministry of Women and Child Development, Govt. of India, for considering complaints of sexual harassment of women at workplace.

The composition of the committee is as follows:

- A Presiding Officer who is a senior women faculty.
- Two members from amongst employees preferably committed to the cause of women or who havehave legalknowledge.
- One member from amongst non-governmental organisations or associations committed to the cause of women or a person familiar withthe issues relating to sexual harassment.

At least one-half of the total members so nominated shall be women Complaint regarding Sexual Harassment against women can be made either in paper form. Aggrieved woman can file the complaint of sexual harassment at workplace to the ICC within a period of three months from the date of incident and in case of a series of incidents, within a period of three months from the date of last incident. In case the aggrieved woman is unable to make a complaint on account of her physical incapacity, a complaint may be filed inter alia by her relative or friend or her co-worker or any person who has knowledge of the incident, with the written consent of aggrieved woman.

3. Anti-Ragging Policy

In pursuance to the Judgment of the Hon'ble Supreme Court, the UGC guidelines and the Prohibition of Ragging Act, Maharashtra, 1999, the following mechanisms are established to ensure a ragging-free campus:

- Wide dissemination of anti-ragging policy and warning through admission advertisements, prospectus and other information booklets.
- Obtaining signed undertaking from students and parents against ragging at the time of admission.
- Constitution of an anti-ragging committee and anti-ragging squad, as
 well as watch and ward arrangements to identify vulnerable locations
 and to keep a constant vigil and watch at such locations.
- Regular interaction and counseling with the students to detect early signs ofragging and identify trouble-triggers.
- Installation of around 45 CCTV cameras at vital points and class rooms.
- Offering Awareness through Cadet with Mother Programme, orientation, mentoring and professional counseling to fresher's to prepare them for the socio-academic life ahead through
- Updated information on Flex boards with the complete contact details of nodal officers and other Committee members related to anti-ragging committee.
- Creating awareness among the students about the functioning of the National Anti-Ragging Helpline having phone number 1800-180-5522 (24x7Toll Free) and e-mail helpline@antiraqqing.in

- 2) Students should not behave rudely with any staff of the college
- 3) Students should not use mobile phones in the classroom
- 4) Intrusive guests should not be allowed to enter the classroom without permission
- 5) Parents should not enter the examination section or the classroom during the examination etc.

The Disciplinary Committee of Shri Dhokeshwar College was constituted as a mandatory body under the provisions of UGC regulations on curbing the menace and indiscipline behavior on campus. The committee addresses the issues of ill incidents on the campus, monitors the performance of a healthy campus environment, and oversees the prevention of any in-disciplinary activity in the institution. The Cell has been actively aware of the indiscipline and unruly behavior of students within the community.

Aims & Objectives:

- 1. The Disciplinary Committee plays a vital role in maintaining discipline in the college. It takes Cognizance of the complaints or allegations received against the students in the college.
- 2. The Disciplinary Committee is to create awareness against any ill incidents occurring within the College campus and prevent them.
- 3. The Disciplinary Committee is to monitor and oversee the duties and performances over the Prevention of indiscipline amongst students.
- 4. The Disciplinary Committee shall regulate the students' behavior by developing well-planned Machinery to take cognizance of indiscipline and unruly menace.
- 5. The Disciplinary Committee may inflict penalties on the students if found guilty of the acts of a misdemeanor on campus.

Respected Sir/Madam,

In pursuance to the Judgment of the Hon'ble Supreme Court of India dated 08.05.2009 in Civil Appeal No. 887/2009, the UGC had notified "Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009". The Regulations are available on the UGC website i.e. www.ugc.ac.in. These regulations are mandatory for all higher educational institutions in the country.

As multiple mechanisms are required to ensure a ragging-free campus, here are some recommendations and action steps which are required to be deployed in your esteemed university and all institutions under your ambit.

A. Basic Measures:

- Constitution of anti-ragging committee, anti-ragging squad, setting up of Anti-Ragging Cell and adequate publicity for these measures through various media are to be undertaken.
- Mention of anti-ragging warning in the institution's prospectus and information booklets
 /brochures shall be ensured
- Updating websites of institutions with the complete address and contact details of nodal officers related to anti-ragging committee.
- 4. In compliance with the UGC Regulations and its 2nd Amendment regarding submission of undertaking by each student and every parent, an online undertaking in every academic year to be submitted.
- UGC has notified 3rd Amendment in UGC Regulations on 29th June, 2016 to expand the definition of ragging by including the following:
 - "3. (i) Any act of physical or mental abuse (including bullying and exclusion) targeted at another student (fresher or otherwise) on the ground of colour, race, religion, caste, ethnicity, gender (including transgender), sexual orientation, appearance, nationality, regional origins, linguistic identity, place of birth, place of residence or economic background."
- Installing CCTV cameras at vital points.

B. Counseling and monitoring measures

- Regular interaction and counseling with the students can detect early signs of ragging and identification of trouble-triggers.
- Surprise inspection at hostels, students accommodation, canteens, rest-cum-recreation rooms, toilets, bus-stands and any other measure which would augur well in preventing/quelling ragging and any uncalled for behaviour/incident shall be undertaken.
- C. Creative Dissemination of the Idea of ragging-free campus
- 1. Events like Anti-Ragging workshops, seminars and other creative avenues to spread the idea.
- 2. Safety and security apps without affecting the privacy of individuals can be creatively deployed.
